Please read the following policy statements carefully. Sign this copy and return with your tuition payment.

I. ATTENDANCE POLICY

Musicians are expected to make Amarillo Youth Orchestra rehearsal, workshops, retreats and concerts a priority. Consistent attendance is necessary for the development of a quality musical experience. Musicians are granted no more than **2 absences per semester**. Two tardies shall constitute one absence. This includes any absence, such as illness, school or other music activities, family vacation, homework and tests, college visits, religious holidays, etc. Absences will not be marked excused or unexcused, but simply as an absence. Musicians who exceed the number of allowable absences per semester will be dismissed from the ensemble.

Absences from dress rehearsals are not allowed in any circumstance. Missing a dress rehearsal will result in forfeiting the right to play that concert.

II. TUITION

All tuition is non-refundable. All funds received by the Amarillo Youth Orchestras **must** be made by check or money order made payable to the **Amarillo Symphony**. **Cash will not be accepted**. Include musician's full name (first and last), ensemble (Sinfonia, Philharmonic or Youth Symphony) in the memo line on each check or money order.

Our organization has made a year-long commitment to the development of each musician. Therefore, even if a student discontinues participation in his /her ensemble, unpaid tuition will still be due.

Tuition: **\$185** for the full season. Tuition is due at the first rehearsal of the season.

Tuition assistance is available to families in need. Contact the youth orchestra staff for additional information.

III. CODE OF CONDUCT

Amarillo Youth Orchestra musicians are ambassadors for the organization, and the behavior of each musician reflects upon the entire group. Each student will be expected to use good manners, display common courtesy, and show consideration for others. A successful AYO experience requires a cohesive group in which each individual accepts and follows the same standards of behavior.

IV. SCHOOL PARTICIPATION

The Amarillo Youth Orchestras are designed to compliment local school instrumental programs. As such, Amarillo Youth Orchestra members are expected to participate in their school music organization provided there is one. Exceptions to this policy will be granted only in extreme circumstances.

V. OWNERSHIP RIGHT

The Amarillo Youth Orchestras own all rights to audio and video recordings.
